



“AGREEMENT” BETWEEN: \_\_\_\_\_

**AND:** OTTAWA TRAVELLERS ATHLETIC CLUB

**REGARDING:** Travellers Adult Summer Ice Hockey League 2012 (“League”)

I/we \_\_\_\_\_ (representative’s name/s),

on behalf of the \_\_\_\_\_ Hockey Team, by my/our signature(s) hereunder, hereby contracts with Ottawa Travellers Athletic Club, and in so doing, signify my/our contractual commitment to enter a team in the aforementioned Travellers Adult Hockey League. As required, I/we also hereby submit a fully completed registration package, including: (1) a non-refundable deposit of **\$395** (three hundred and ninety-five dollars, along with the additional required entry and bond cheques as noted in the Summer 2012 Registration Information on the Travellers web site at [www.ottawatravellers.ca](http://www.ottawatravellers.ca), and as indicated below, plus (2) the fully completed **TEAM INFORMATION FORM**, (3) **TEAM ROSTER/CALIBRE FORM**, (4) the team **Bond** (if or as required), and (5) this signed **AGREEMENT**. Cash payments for entry fees or bond will not be accepted. Deposit and post-dated cheques will be returned in full if team rejected.

1. Teams will play 20 games, including season and play-offs, from approximately mid-April to mid-August, 2012, with the 5<sup>th</sup> and 6<sup>th</sup> place teams after the play-off round-robin playing one less game.
2. The team entry fee for the 2012 summer season is **\$4,195** (includes new HST) if fully completed registration is received by Feb 20, 2012, **\$4,295** if received after Feb 20, 2012, or **\$4395** if received after Mar 7, 2012.
3. Teams must submit initial cheques/payments along with post-dated cheques/payments for the balance in accordance with the registration information provided and as follows.
  - 1<sup>st</sup> cheque: \$ 395 non-refundable deposit dated today
  - 2<sup>nd</sup> cheque: \$ 1925 dated April 25, 2012
  - 3<sup>rd</sup> cheque: dated May 23, 2012 for either:
    - \$1875 if registration received by February 20, 2012
    - OR > \$1975 if registration received after Feb 20, 2012
    - OR > \$2075 if registration received after Mar 7, 2012
4. **FULL PAYMENT OPTION**> Balance of entry fee (after initial deposit of \$395) received and payable in full to Travellers on or before April 25, 2012, will be accepted at the full early-bird discounted rate of \$4195.

**NOTE** > The League reserves the right to require payment in full of a team’s entry fee prior to start of season.

5. **Team Bond:** Unless your team already has a \$150 returnable team bond held by the League, a separate returnable **\$150 bond cheque** dated no later than April 30, 2012, is required to be submitted with your registration.
6. I understand and agree that the **\$150 returnable team bond** will be applied towards any fines or charges (i.e. cancelled/NSF cheques, sweater rentals, property damages, penalty fines, forfeits, etc) that our team or individual players may be assessed. If a team bond held by the league has dropped below \$150, this bond must be topped up to \$150 when requested by the league. Balance of team bonds will be held and carried over by the League until the next season, unless team indicates it will not be returning. League reserves the right at its discretion to increase the amount of team bond required to an amount above the standard \$150. No interest is applied to bonds.
7. I understand that the League has the right to impose a “**Personal Bond**” on an individual player where warranted.
8. **NSF Cheques and Late Payments:** Should a team’s cheque be returned NSF, or if for any other reason a payment of any kind is past due, an automatic minimum **\$35** fine will be deducted from the team bond if this is teams’s first NSF within past 3 years. A 2nd NSF cheque or late payment within the past 3 years will result in a \$50 fine. Any team making 3 or more NSF cheques or late payments

during its years in the Travellers League will be fined \$75 for each subsequent NSF cheque or late payment. This applies notwithstanding Rule 16.2.

9. **The Schedule of Fines & Penalties** is posted on Travellers web site at [www.ottawatravellers.ca](http://www.ottawatravellers.ca). The League, at its discretion, reserves the right to apply additional or other fines not listed.
10. **Balanced Play:** I understand and agree that the League is solely responsible for placement of teams in divisions whereby balanced play and over-all benefit of all teams are the main criteria for a team's ranking and placement.
11. **Roster Changes after Divisional Re-Alignments:** The league reserves the right to prevent a new player from joining the League after divisional re-alignments, whereby maintaining divisional parity will be the main criterion for refusal or acceptance.
12. **Player Identification:** I understand and agree that any player wishing to play on this team may at any time be required by the League to provide picture I.D. and, at the League's discretion, any player may be denied entry to the League.
13. **Admin Penalties:** The League reserves to right to apply "**Admin Penalties**" in games against teams who have failed to fulfill League administrative requirements. A team would play a man short during Admin Penalties.
14. **Game Forfeiture \$150 Fine: Rule 19 >** By signing this contract, I and my team hereby agree that if my team is unable to ice enough players to allow for a proper game, my team will be assessed a \$150 fine which is immediately due and payable to the opposing team. This is a contractual arrangement that is binding on and amongst all teams in the League and payment and collection is handled between the two teams on the honour system without intervention of the Travellers League. At the request of the aggrieved team, failure to pay would result in imposition of Admin Penalties and the offending team may not be permitted to return for future seasons.
9. **Sweaters:** All players on the same team **MUST** wear **IDENTICAL** sweaters in accordance with League rules, or be subject to fines as indicated in the League's Penalties, Fines & Fees Schedule.
10. **Equipment:** The onus is on the individual player and the team reps to ensure that all players are wearing the proper and CSA approved equipment, including full under-padding and protection from the waist down and at least elbow pads from the waist up. All helmets and goalie masks must be CSA approved with **NO** missing/broken parts, they must have proper chin straps (no tape), and helmet clips must be removed when not being used. If spotted, a player with non-conforming helmet or mask will receive an "illegal equipment" minor penalty and will not be permitted to return to the ice until it is corrected or replaced.
11. **Penalty Minutes:** A player amassing penalty minutes in excess of the limits permitted will be subject to fines/penalties as indicated in the Schedule of Fines & Penalties, such fines to be deducted from the Team Bond.
12. **Ejection:** I/we agree that our team or any player on our team may be ejected from this League for "just cause" (e.g. displaying continual lack of respect or unacceptable aggression toward opposing players, referees, or League officials, intent to injure, etc). In the case of a player ejection, I/we agree that no re-imbursement of any kind will be made by the League. In the case of a team ejection, the League reserves the right to retain the entire balance of the team entry, or minimally, a pro-rated equivalent of an additional three games from the time of ejection.
13. If a shortage or cancellation of hours available to the Travellers Club results in insufficient hours to complete the full schedule, the Travellers Club reserves the right to reduce the number of games played by each team, and to adjust and reduce the team's entry fee for the season.
14. Any regularly scheduled and/or play-off games that cannot be played at scheduled date and time due to arena commitments to other clients and/or unforeseen problems, will be re-scheduled at another time, and possibly another location. Re-scheduled or re-played games may take place on days, dates or hours that may not coincide with days, dates or hours promised or intended by the League for regular play.
15. Final acceptance of a team into the League will be at the discretion of the League Officials and/or Travellers Club management.
16. I have read and understand the terms of this application and contract and agree to inform all my team's players of all conditions contained therein as well as the League's Rules and Regulations.
